Terms & Conditions

The following are the terms and conditions for use of the Strata Furniture Website

WEBSITE: USE AND SECURITY

You are entirely responsible for any and all activities that occur under your account which is provided to you by Strata Furniture who provide the transactional element of the website. You agree to notify us immediately of any unauthorized use or any other breach of security.

WEBSITE: PRIVACY & DATA USE

WEBSITE: CONDUCT

PRICE OF GOODS

Bespoke manufactured items will have a longer lead time associated. Any dates specified for delivery are therefore approximate only. We will not be held responsible for any other losses, costs, damages or charges that you may suffer if we delay in supplying or do not supply those Products. At the time of delivery you will be required to validly sign-off on the delivery of the Products, after which time the Products become your sole responsibility.

CLAIMS

We are a business-to-business supplier so The Distance Selling Regulations do not apply, however any products returned within 7 days must be unused and in a resalable condition. Any breakages or damages must be reported within 48 hours of delivery. Unless there is a manufacturing fault we do not accept returns on our furniture. Please ensure you have ordered the right goods and in the correct quantities.
